C WTSatoTravel has been awarded an E-Gov Travel Services-2 (ETS-2) Master Contract by the U.S. General Services Administration (GSA). ETS-2 is the second generation travel management program, built on the success of ETS-1, which will help the government further consolidate online travel booking services and expense management platforms to drive cost savings and efficiencies.

This contract award was based on GSA's determination that CWTSatoTravel met the technical requirements established in the ETS-2 solicitation. It will enable CWTSatoTravel to service federal agencies through the E2 Solutions application service that was deployed under the ETS-1 Master Contract over the past 10 years.

CWTSatoTravel President Discusses Benefits of a Travel Management Program

Recently an article written by CWTSatoTravel president, Matt Beatty, was featured in Government Executive. "You May think You Know How to Save Your Agency Money on Travel" focused on the benefits of an effective travel management program. Here is an excerpt of the article. "Intense pressure on federal agencies to reduce costs has been particularly visible in the area of travel. In May 2012, the Office of Management and Budget directed agencies to reduce travel spending by 30 percent from fiscal 2010 levels, which was followed by sequestration in March 2013, and stories of government travel excess. This environment has created arduous challenges for agencies in managing their travel dollars.

Many have reduced travel costs by choosing lower airfares, limiting hotel bookings, reducing or sharing car rentals and, in some cases, canceling trips altogether. What's surprising, though, is that some federal entities aren't fully optimizing their travel programs. A bigger concern is that agencies are advising employees to avoid using approved travel management companies and arrange trips directly with airline, car rental and hotel vendors.

On the surface, bypassing these contractors may seem like a simple way to save money. What agencies might not know is that in the long run this approach will likely result in higher costs and more risk.

Teaming with travel management contractors -- whose fees generally represent less than 2 percent of an agency's overall travel costs -- can help agencies optimize spending, provide better services to their employees and travel managers, boost security on the road and save time."

Per Diems Change after Year-Long Freeze

The General Services Administration (GSA) increased per diem rates for fiscal year 2014 in most markets.

The government Continental United States (CONUS) standard lodging per diem increased \$6 from \$77 to \$83. The standard rate applies to 2,600 counties. About 400 Non-Standard Areas (NSAs) will continue to have rates higher than the standard rate including Big Spring, TX and Pearsall, TX – two new additions for 2014.

Twenty-nine locations moved from a NSA status into a standard CONUS status including Winston-Salem, NC and Montgomery, AL. Some NSA locations will see a decrease in rates including Washington, D.C. which will drop to \$219 from \$226. For a list of all per diem rates, please visit <u>gsa.gov</u>.

Per diem rates are the set maximum allowances that federal employees traveling on official business can be reimbursed for lodging and food while traveling. GSA is responsible for establishing rates in the lower 48 Continental United States.
